Pendleton Public Library (2 projects)

Description: Funding for two projects, the first is to support the launch the first Lego League of eastern Oregon and the second is to purchase STEAM education items for their Library of Things Collection.

Description: Update to Oregon Trail exhibit to highlight trails through and stories of Umatilla County.

Catheryn Pratuch (individual)

Description: For the creation of little free pantries as part of a grassroots movement of neighbors feeding neighbors.

Description: To launch weekly STEAM based activities that help build family and build community connections.
